The Institutional Prime Money Market Fund pursues its objective by investing in high quality, short-term money market instruments such as securities backed by the full faith and credit of the U.S. Government, securities issued by U.S. Government agencies, or obligations issued by corporations and financial institutions. The Fund maintains a floating net asset value rounded to the fourth decimal place.
